


Alexey Tsykarev's career has primarily developed in the civil society from being a national minority activist in the Republic of Karelia to heading the International Youth Association of Finno-Ugric Peoples. Currently, Mr. Tsykarev is serving as an Expert Member at the United Nations Human Rights Council's Expert Mechanism on the Rights of Indigenous Peoples. He has worked for the World Bank and Erik Castren Institute of International Law and Human Rights in the University of Helsinki. Locally, Alexey Tsykarev is chairing Center for Support of Indigenous Peoples and Civic Diplomacy "Young Karelia". The organization is focused on preservation, promotion and development of endangered Finno-Ugric languages and culture.



Alina Nechaeva is director of the fund "Resources" operating in St. Petersburg. In 2007 – 2011 she worked for the Government of the Leningrad region as Head of the Department for Interaction with Non-Profit Organizations. In 2011 – 2013 she headed the Department for Interaction with Indigenous Peoples. Graduated from St. Petersburg State University, Faculty of political science.



Oliver Loode is currently working as Expert at the Estonian Institute of Human Rights, focusing on indigenous peoples' rights. During 2014-2016 he served as Member of United Nations Permanent Forum on Indigenous Issues (UNPFII) where he was responsible for Culture and Tourism thematic portfolios. During 2015-2017 Oliver worked as Head of Cultural Programmes at Minority Rights Group International (UK). Since 2011, Oliver has been involved in Finno-Ugric activism, including as board member of the Youth Association of Finno-Ugric Peoples (MAFUN) and as one of the initiators of the Finno-Ugric Capital of Culture programme.



**Vladimir Efimov** is an activist in the Izhorian community «Shoikula» in Leningrad region, responsible for public relations. He currently studies very endangered Izhorian language and performs in an Izhorian dance ansemble.



**Galina Lukyanova** is a lecturer at the St. Petersburg State University. She holds PhD in Political Sciences and membership in the International Political Science Association and the Russian Association of Political Science. She is engaged in studying framing and technologies for formation of public opinion, and ethnic identity issues. Galina is an ethnic Ingrian.



Svetlana Kolchurina is Director in the Association of Ethno-Cultural Centers and Heritage Organizations of the Republic of Karelia «ECHO». Her work is primarily dedicated to the preservation and up to date development of handicrafts and traditional arts of indigenous peoples and ethnic minorities. She also served as Vice-President of the International Youth Association of Finno-Ugric Peoples and participated in the UN Indigenous Fellowship Programme.



Elena Yakovleva is President of the Association of the Kola Sami and member of the Board in the Association of Indigenous Peoples of the North, Siberia and the Far East of the Russian Federation (RAIPON). She is a deputy chair in the Council of Representatives of the Indigenous Peoples of the North under the Government of the Murmansk region and a deputy chair of the Sami Assembly Sam Sobbar, a decision-making body of the Russian Sami movement.
